AN ORDINANCE OF THE BOROUGH OF PORT CARBON, COUNTY OF SCHUYLKILL, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2025 AT 17.149 MILLS

AN ORDINANCE OF THE BOROUGH OF PORT CARBON, SCHUYLKILL COUNTY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATES FOR THE YEAR 2025

WHEREAS, the Borough of Port Carbon is required to annually ordain its real estate tax rate under the Borough Code at 53 P. S. §46310 following adoption of its annual budget;

WHEREAS, the Borough of Port Carbon, as part of its budget publication process, advertised its millage rate at 17.149, and said budget has been opened to public inspection;

NOW THEREFORE BE IT ORDAINED, and it is hereby ordained and enacted by the Borough Council of the Borough of Port Carbon, County of Schuylkill, Commonwealth of Pennsylvania, that a tax be and the same is hereby levied and increased on all real property and occupations within the Borough of Port Carbon subject to taxation for the fiscal year 2025 as follows:

1. Real property tax assessment is hereby fixed at 17.149 mills for general purposes on each dollar of assessed property valuation, representing a rate of \$1.7419 cents on each \$100.00 of assessed valuation of taxable property.
2. Local Services Tax is hereby fixed at \$52.00 (\$5.00 School District, \$47.00 Borough)
3. Eared Income Tax one-half percent (1/2%)

4. Real Estate Transfer Tax 1 %
5. Per Capita \$5.00
6. Occupation \$8.75
7. The garbage fee for 2025 will increase to \$400.00 per household, to be paid in quarterly installments of \$ 100.00
8. Business Privilege Tax-

### **Business Privilege Tax**

There is hereby levied for the tax year 1982 and annually thereafter a tax for general revenue purposes on the privilege of doing business as herein defined in the Borough as follows:

- A. The rate of the tax on each and every dollar of the whole or gross volume of business transacted within the territorial limits of the Borough shall be 1 ½ mills. One- and one-half mills shall mean \$1.50 per \$1,000 of gross volume of business, except that the rate of the tax on each and every dollar of the whole or gross volume of business transacted by wholesale dealers or wholesale vendors within the territorial limits of the Borough shall be one mill.
- B. All non-wholesale business of such wholesale dealers or wholesale vendors shall be taxed at the general rate if 1 ½ mills.

All ordinances, or parts of ordinances inconsistent with this ordinance be and the same are hereby repealed.




